

## LyondellBasell’s Task Force on Climate-related Financial Disclosures Index

LyondellBasell has identified that the long-term effects of climate change could present a material impact to our business model, assets and sites. In 2021, we began using the Task Force on Climate-related Financial Disclosures (TCFD) Guidance to develop our climate change risk management process to support further analysis of risks from climate change. This process, which we have continued to use throughout 2022, is embedded in our Enterprise Risk Management (ERM) approach and supports the identification of transitional and physical risks and the development of climate scenarios to provide additional insight into future business decisions and inform our climate change strategy.

By having a clear understanding and targeted approach to climate change risk management, we aim to help identify, assess and manage the risk exposures throughout LyondellBasell. Our objective is to help the company plan for the future, build climate resilience and minimize hidden risk exposures; therefore, ultimately reducing uncertainty in the future.
